AN ORDINANCE AMENDING ORDINANCE NO. 132 RELATING TO THE KEEPING, HANDLING, AND VACCINATION OF CERTAIN ANIMALS WITHIN THE TOWN OF DOVE CREEK, AND AMENDING THE LICENSE FEES OF SAID ORDINANCE.

1. BE IT ORDAINED by the Board of Trustees of the Town of Dove Creek, Colorado that Section 2:2-3 FEES: be amended to read in it's entirety as follows: **Four (4) dog limit within the City limits.**

**FEES:**                                **SECTION 1:**

**One (1) through three (3) dogs:**

| Male   | \$10.00 ea. dog | Neutered | \$5.00 ea. dog |
| Female | \$10.00 ea. dog | Spayed   | \$5.00 ea. dog |

**Fourth dog:**

| Male   | \$50.00 | Neutered | \$25.00 |
| Female | \$50.00 | Spayed   | \$25.00 |

This Ordinance would exclude any existing State licensed kennel operation under current ownership within the Town of Dove Creek.

**SECTION 2**

The Town of Dove Creek Board of Trustees may by resolution change all of the aforementioned fees as deemed appropriate or necessary by the said Board of Trustees.

**SECTION 3**

**SEVERABILITY:** The Board of Trustees hereby finds, determines, and declares that this Ordinance is enacted in severalty, and if any portion thereof be held unconstitutional, the entire remaining portion shall remain and be in full force and effect.

**SECTION 4**

All ordinances or portions of the same in conflict with the Ordinance or which cover the same matters herein are hereby repealed.

**SECTION 5**

The Ordinance shall take effect on the 19th day of April, 2007.

**SECTION 6**

The Board of Trustees of the Town of Dove Creek finds determines and declares that this Ordinance is necessary for the immediate preservation of the public health, welfare and safety.

Passed, adopted and approved by the Board of Trustees on first reading the 15<sup>th</sup> day of February, 2007.
