### Letter from Town Board Trustee

It is a privilege to be able to share some of the Town of Dove Creek's news with you in this first newsletter to the community.

The Town has many projects in the works and has high hopes for improvements in infrastructure, long-term planning, our parks, and our new town office on Highway 491. Other projects include a greatly-needed additional water storage reservoir as well as formalization of the Dolores River Line repair Project that has been being pursued by the Mayor and Board of Trustees these last several years.

In September, the Town was awarded an \$800,000 grant for the additional water storage reservoir and on January 24, 2022 the Colorado Water Conservation Board (CWBC), a low interest loan was approved for the remainder of the reservoir project, depending on loan contingency. This is a huge step toward water availability and independence for our community, especially in these frequent years of drought.

The Town remains committed to continued Code Enforcement in the community with cleanup days and ongoing support. The purchase of a used air curtain burner enables the citizens of Dove Creek to dispose of tree limbs at the current town office maintenance yard and specific days will be set up for community members to haul them to it. The Town now has the ability, with the air curtain burner, to efficiently and cleanly dispose of them in a timely manner, with very little waste remaining. Look for a schedule in a subsequent newsletter with details.

The Mayor and Board are enthusiastic and excited for the new proposed improvements and projects in out town and they, along with your town's stellar maintenance crew and office staff are working diligently, as a team, to make some of these projects and improvements a reality. It is an uphill battle to identify, pursue and secure those funding opportunities that are available to those who are not really willing to take "No" for a first response, but rather see it as an opportunity to ask, "Well then, what is our next right step?" This "team" that works for the community of Dove Creek, are just those kinds of people, and I feel blessed to be part of that team and this community. Gratefully,

# Water and Sewer Utility Bills

Water and Sewer Utility Bills are due on the **15th** day of the month. A late charge of \$5.00 will be added for unpaid bills after the 15th of each month regardless if a bill is received by customer.

#### **Friendly Reminder**

Please keep all water meter pit lids free and clear of landscape materials, sod, dirt, debris, weeds, etc. This will assist Public Works with your water meter reads each month.

#### Cats

All pet cats within Dove Creek Town Limits are asked to have a collar. This allows Animal Control to distinguish between a pet and a stray.

#### **Dog Licenses and Tags**

All dogs within Dove Creek Town Limits must be licensed with the Town Office. To obtain a license proof of rabies vaccination is required.

If you have 1-3 dogs the cost is:

- \* Altered—\$10.00
- \* Unaltered—\$15.00
- \* Tag replacement—\$2.00

The fourth dog

- \* Altered—\$30.00
- Unaltered—\$55.00
- \* Tag Replacement—\$2.00 Limit of 4 dogs in city limits.
